RESULTS AND DISCUSSION

RESULTS AND DISCUSSION:

Test DPG13-01A consisted of one-hundred (100) adults (50-70 years of age) being tested in nine (9) sites from January 3, 2013 through January 22, 2013. This test is a one-hundred (100) unit senior-adult (50-70 years of age) resealing protocol as set forth by the C.P.S.C., and published in the Federal Register on July 21, 1995 pgs. 37710-37744 re 16 CFR part 1700.15 and 1700.20.

The results of this study are as follows.

1) NONE (0) of the senior-adults failed to open their first package.

- Refer to Adult Resecuring Test Detail Report

2) NONE (0) of the senior-adults failed to open their second package.

- Refer to Adult Resecuring Test Detail Report

3) There were TWO (2) child openings (refer to DPG13-01CR - Child Portion)

4) Since less than 20% of the packages ($100 \times 0.2 = 20.00$) were opened by the children (refer to test DPG13-01CR - Child Portion), no subtraction in score was needed from the senior-adult (SAUE) opening and resealing results.

5) The C.P.S.C. requires a SAUE of no less than 90.00%

6) The SAUE for this package is 100.00%

7) Based on the results of this test, the submitted package meets the senior-adult criteria set forth by the C.P.S.C., as published in the Federal Register dated July 21, 1995 pgs. 37710-37744 re 16 CFR part 1700.15 and 1700.20
