## First Year Report of Malaria Elimination Demonstration Project (MEDP)

<u>House to house malaria treatment started for entire district</u>

<u>MEDP Program Develops SOCH – Solution for Community Health-workers: A mobile surveillance</u>

tool for malaria workers

<u>JABALPUR, MADHYA PRADESH, MARCH 23, 2018:</u> Malaria Elimination Demonstration Project (MEDP) in Mandla, Madhya Pradesh has successfully completed one year. The project is a first-of-its-kind public-private-partnership between the Indian Council of Medical Research (ICMR), Government of Madhya Pradesh (GoMP), and the Foundation of Disease Elimination and Control (FDEC), established by Sun Pharma as part of its Corporate Social Responsibility initiative. In the first year, the entire 10.5 lakh population of Mandla was tracked, 46,839 fever cases were tested and 206 (0.44%) cases of malaria were found positive and treated. MEDP project has also developed a mobile surveillance application **SOCH – Solutions for Community Health-workers** that will digitize all the paper work and enable a more efficient and real time information sharing on the project.

The project is in line with the vision of Hon'ble Prime Minister, Shri Narendra Modi to eliminate Malaria by the year 2030. The goal of MEDP is to successfully eliminate Malaria from the 1233 villages in Mandala district, so that the lessons learned can be used in rest of the state and country. "Malaria is a major health problem in India, especially in the tribal and rural areas. India contributes to approximately 89% of Malaria cases in South East Asian Regional Countries. MEDP is first of its kind public-private partnership with a goal to demonstrate malaria elimination. As part of our effort, we place emphasis on informing, educating and communicating with local communities and seeking inputs and contributions of various local stakeholders said", Dr. Altaf Lal, Senior Advisor Global Health and Innovation – Sun Pharma.

"The Mandla office was established as a part of three party agreement between FDEC, Govt. of MP and ICMR signed on the 15<sup>th</sup> of November 2016. A five-day training program was conducted for Malaria Field Coordinators and Village Malaria Workers. The training session helped in improvement of knowledge in 95% of the participants post the training said", Dr. Azadar Khan, Senior VP Corporate Affairs, Sun Pharma.

"The government of MP's contributions have been significant through participation at local level and by providing bed nets and conducting household sprays which are important in malaria elimination efforts. We look forward to continuing in this project with FDEC India and extending the learnings to other parts of the state", said Dr. Himanshu Jayswar, State Programme Officer - Govt of MP, Bhopal.

The first step in the process of eliminating Malaria is to Track, Test and Treat (T3). The T3 process has been developed and conducted under the strict supervision of the scientists from the ICMR- National Institute for Research in Tribal Health (NIRTH) and MEDP staff in order to ensure the right kind of learning in the first attempt. As a part of the prevention method Long Lasting Insecticide Treated Bed Nets (LLIN) were distributed by the state of Madhya Pradesh along with regular indoor residual spray.

"We utilize Rapid Diagnostic Test kits as our key-diagnostic tool for Malaria on the field. The tool has been quality assured by ICMR-NIRTH and has shown 100% accuracy. We identify cases rapidly and treat promptly. From September 1<sup>st</sup> 2017 to February 28<sup>th</sup> 2018, MEDP has tested 46839 fever cases and treated 206 positive cases of Malaria." said, Dr. Aparup Das, Director, ICMR – National Institute for Research in Tribal Health (NIRTH), Jabalpur
