

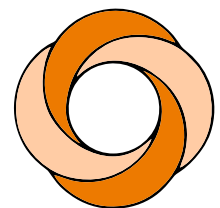

Message from Managing Director & Chairman – CSR Committee

At Sun, we continuously strive to make good health accessible to all. This commitment is extended not only to our patients but also to the local communities around our areas of operations.

Our focus is on creating a 'sustainable business model' which combines ethical business strategies, active stakeholder engagement, multi-sectoral partnerships and building social institutions. Sun Pharma has made diligent efforts to evolve its CSR strategies and practices to benefit the local communities and the underserved. Our social efforts cover various domains such as health, education, water & sanitation, ecology and environment, and rural development. Together, they contribute to the physical, social and economic development of individuals, families and communities.

In 2016-17, we worked with communities across 11 states to achieve sustainable and holistic development. We witnessed increasing community participation and ownership in these states. Be it cleanliness and tree plantation drives, management of local medical clinics or setting up of rural infrastructure. We also built partnerships with local NGOs, administrative bodies and community-based organisations.

Malaria is a major public health problem in India, especially in rural/tribal areas of the country. According to the 2017 World Malaria Report, India contributes ~80% of malaria cases in South East Asia Regional (SEAR) countries. India has the highest number of deaths outside the African continent, with approximately 183.5 million at high risk and 1.2 billion at low and high risk. Tribal areas are considered as the 'heartlands of malaria', and elimination from 'heartlands' is expected to have national level impact. The World Health Organization (WHO) and Roll Back Malaria (RBM) have prepared materials and strategies for a malaria-free world by 2030. SEAR countries have also identified 2030 for malaria-free Asia Pacific. Our Hon'ble Prime Minister, Shri Narendra Modi along with other heads of Indian states have committed to this target. Malaria Elimination Demonstration Project (MEDP) is a first-of-its-kind public-private-partnership between the Indian Council of Medical Research (ICMR) through the National Institute for Research in Tribal Health (NIRTH), Government of Madhya Pradesh (GoMP), and the Foundation for Disease Elimination and Control of India (FDEC-India), established by Sun Pharmaceutical Industries Ltd. as a not-for-profit entity. The goal of MEDP is to demonstrate successful elimination of malaria from 1233 villages of Mandla district and use the lessons learnt for eliminating malaria from rest of Madhya Pradesh and the country. In the first year of the project, we have recruited, trained and deployed field staff in 1233 villages, initiated active surveillance, testing for malaria by rapid tests and treating malaria cases with appropriate drugs. We have conducted training for needs assessment of ASHA workers and have provided the results to State Govt officials. We have also developed information, communication and education materials for informing communities about prevention and control of malaria. We have conducted two Malaria Elimination Advisory Group meetings so far to share data and seek comments and feedback of external reviewer and stakeholders. Our CSR team, along with various stakeholders, has done a commendable job. We have created various milestones in the direction of creating sustainable and self-sufficient communities. In the coming year, we will continue to focus and dedicate ourselves to realise our CSR vision of developing sustainable communities and achieving inclusive growth.

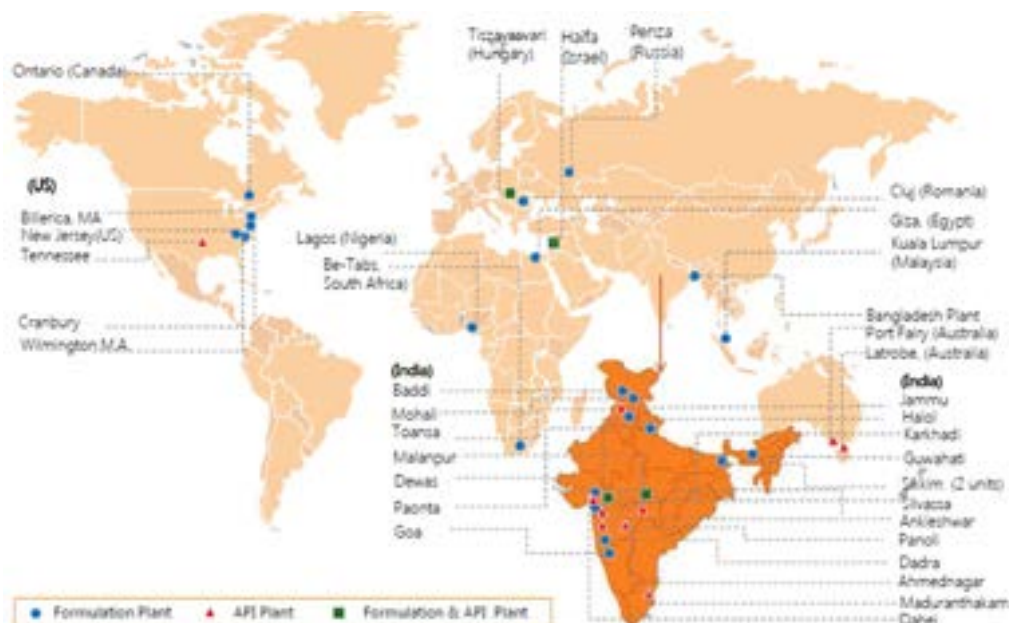

Sun Pharma has always been committed to provide preventive and curative healthcare in remote, underserved and inaccessible areas. This is achieved through two major initiatives.

1 Mobile medical units (MMUs):

Guided by the National Rural Health Mission's (NRHM) vision of ensuring all people in the country can access quality and affordable health services, the Sun Pharma operated MMUs provide free-of-cost medical check-ups and medicines to villages in and around its areas of operation. Equipped with qualified medical staff, the MMUs improve the accessibility to primary healthcare for isolated communities.



The MMU is a health service that is conveniently available and accessible to all. It is especially a boon for individuals and families who have economic barriers and constraints in visiting hospitals. The regular health check-ups, provision of medicines, hospital referrals and follow-ups done by the MMU has brought noticeable improvement in the health status of communities.

A sudden fall while working resulted in a fractured knee for Nanjibhai Parmar. Even though he underwent a surgery to correct his knee, post-surgery he started experiencing severe pain and swelling. It was during this time that he decided to visit the MMU operated by Sun Pharma in his village. The medical consultant assessed his injury and recommended the suitable medication and care. He has been following these recommendations and also goes for regular checks and follow-ups. "Thanks to the MMU, with its qualified team, there has been a progress in my physical condition without me having to travel too far or spend too much money", he says as an expression of his gratitude towards the MMU.

PRIMARY HEALTHCARE TO A SENIOR CITIZEN...

Giddiness, muscle pain, weakness and skin irritation were few of the health concerns afflicting 85-year-old Shabai Katke. These health concerns in her advanced age were negatively impacting her basic mobility and functioning. But due to financial constraints, it was impossible for Shabai to avail treatment at the local clinics and hospitals. Her condition started deteriorating rapidly and a neighbour suggested she consult the MMU that visits her village regularly. She availed the facilities of the MMU and is thankful for it, "After my first visit I experienced slight relief from my intense physical discomfort. I became a regular patient of the MMU. Even though my health has not completely improved, there has been good improvement in my mobility."

SECURED HEALTHCARE FOR INDIVIDUALS EXCLUDED FROM GOVERNMENT ENTITLEMENTS AND BENEFITS...

75-year-old Karna Mukhia registered himself at the MMU visiting his village with the objective of being cured or at least partly relieved from his long-standing health concerns like abdomen pain, breathlessness and constant feeling of weakness. Being supported by his grandchildren, who are daily wage labourers with a cumulative income of Rs. 5000 to 8000 per month, Karna did not want his healthcare to become an additional financial burden for them. Also, residing on the outskirts of Sikkim, with no relevant identity proofs in place, he could not avail any government schemes that provide subsidised healthcare to economically weak sections. In this dire situation the MMU proved to be a boon for him. Regular visits to the MMU have now stabilised his blood pressure and controlled his dyspnea (breathlessness). He states, "Regular access to quality healthcare and medication would not have been possible without the direct aid from the MMU."

SUPPORTIVE TREATMENT AND CARE TO AID PRIMARY TREATMENT...

From the time Ganga Ram Rai first associated with the MMU, he was undergoing directly observed treatment, short course (DOTS) for tuberculosis (TB) at the primary healthcare centre (PHC) in Ranipool, Sikkim. He approached the medical team at the MMU with complaints of extreme weakness and body ache. His blood sugar was also constantly fluctuating. Health tests, conducted by the MMU team as well as through hospital referrals, revealed that his health concerns were a result of adverse side-effects of the TB drugs. Supportive treatment was initiated for him by the MMU. Apart from medical treatment, he was also advised to make certain changes to his diet. When asked about his current health status, he stated, "I am continuing with my TB treatment from the primary health centre (PHC) as well as supportive treatment at MMU. I feel the supportive treatment has strengthened me physically and my body is able to react better and quicker to the TB treatment."

2 Health awareness camps:

For more rigorous emphasis on preventive health, camps were organised to increase community awareness on prevalent local health concerns and measures to prevent them from occurring. Camps were conducted in 14 villages of two states on topics like tuberculosis, mental health, depression, adolescent health and general seasonal illnesses.

Health camps reached out to 1277 individuals including Panchayat representatives, Integrated Child Development Services (ICDS) members, students and other community stakeholders.

Apart from activities directly aimed towards prevention and cure, repair and upgradation of health infrastructure is also undertaken to ensure access to quality essential healthcare services for communities in remote rural areas. As part of this, repairs of a dispensary were undertaken in the Balachaur block of Nawanshahr district, Punjab. Sun also supplies basic medicines to the dispensary on a regular basis. This is in addition to the medicines already supplied to the dispensary as part of government provisions.

The targeted healthcare initiatives reached out to 18277 individuals.



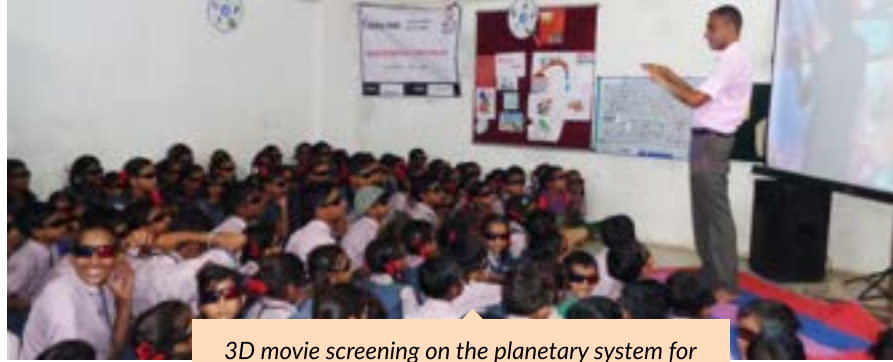

The concept of a 'model school' was introduced by the Ministry of Human Resource Development (MHRD). It emphasises on high quality infrastructural amenities, balanced pupil-student ratio, information, communication and technology (ICT) and appropriate curriculum for a school environment that promotes a culture of learning. Sun Pharma has adopted and is focussed on the development of 'model schools' to ensure inclusive and equitable quality education for all. Various activities to create model schools were implemented in the states of Tamil Nadu, Gujarat, Punjab, Sikkim and Dadra and Nagar Haveli. The activities conducted largely emphasised on the following:

Growth and development of students through balanced curricular and co-curricular activities

Infrastructure development specifically focused on ensuring availability of basic amenities in the school environment and enhanced safety of students in the school premises

Making available computers to integrate ICT into the education models of government schools in rural areas

1920 students covered as part of curricular and co-curricular growth support

2500 students covered as part of building and upgrading education facilities

980 students benefitted from ICT in education

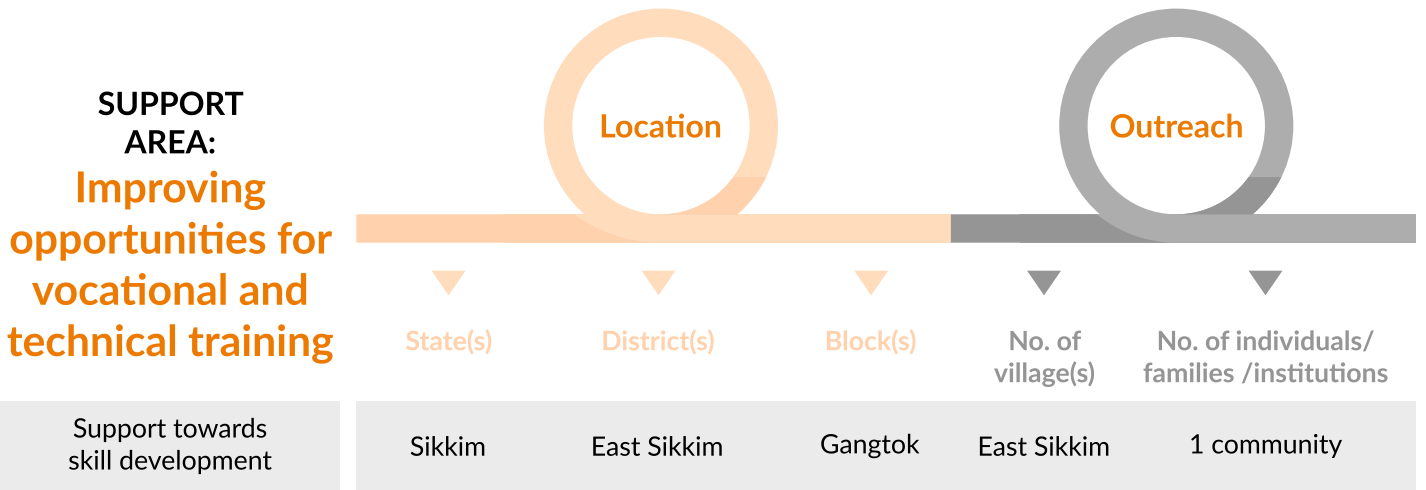

Sustainable lifestyles are promoted among students by conducting sessions and events to sensitise them on social, cultural and environmental concerns.

Cultural events like Republic Day were celebrated with 350 students in four schools of Nawanshahr district, Punjab. In the state of Sikkim students were made aware about the dangers of substance abuse during a special session to commemorate World Tobacco Day. World Environment Day was also celebrated, primarily through tree plantation drives. Essay and drawing competitions on cleanliness were also conducted in schools of Silvassa block in Dadra and Nagar Haveli to inculcate in students the habit of keeping their immediate surroundings tidy.

In Sikkim, Sun Pharma extended partial support to the Sikkim Skill Development Mission to establish a pharmaceutical institute in the state. This benefitted the community located in East Sikkim.

Domain 3: Providing clean water and sanitation

Good health of individuals and communities is largely determined by the availability of clean drinking water and amenities for sanitation and hygiene. Apart from global goals on clean water and sanitation, even national goals like the Swachh Bharat Mission (SBM) emphasise on promoting clean drinking water and well-equipped sanitation facilities for all. Successfully achieving these targets in both rural and urban India will require active collaboration and partnership between the government, non-governmental organisations and corporate bodies.

Sun Pharma has been making diligent efforts to achieve universal access to safe and affordable drinking water. They primarily focus on increasing water availability for communities and infrastructure maintenance and construction for increased water availability. Active contributions have also been made for adequate and equitable sanitation and hygiene for all. This is done through construction of and training on usage and maintenance of individual household toilets (IHHTs) as well as through campaigns and drives to promote sanitation.

Water was supplied for drinking as well as regular use to households as well as institutions at different plant locations. While access to safe drinking water was ensured to 125 households of one village in Balachaur block of Punjab, 98 households in Ahopul area of East Sikkim were supplied water daily to meet everyday requirements. Schools in the states of Gujarat, Maharashtra and Sikkim were also provided with amenities like RO systems and water purifiers to secure good health for children. Water purifiers were installed at six different government schools in rural areas of East Sikkim to increase availability of use of safe drinking water. Water coolers and water purifiers were installed at two rural schools in Ahmednagar, meeting drinking water need of 202 students. A water purifier and cooler was also provided to one primary healthcare centre (PHC) in Halol block of Gujarat, meeting the drinking water needs of 2600 individuals who visited the PHC throughout the year.

A total of 11 institutions – including one PHC and 10 schools - were provided with facilities to secure availability of clean drinking water

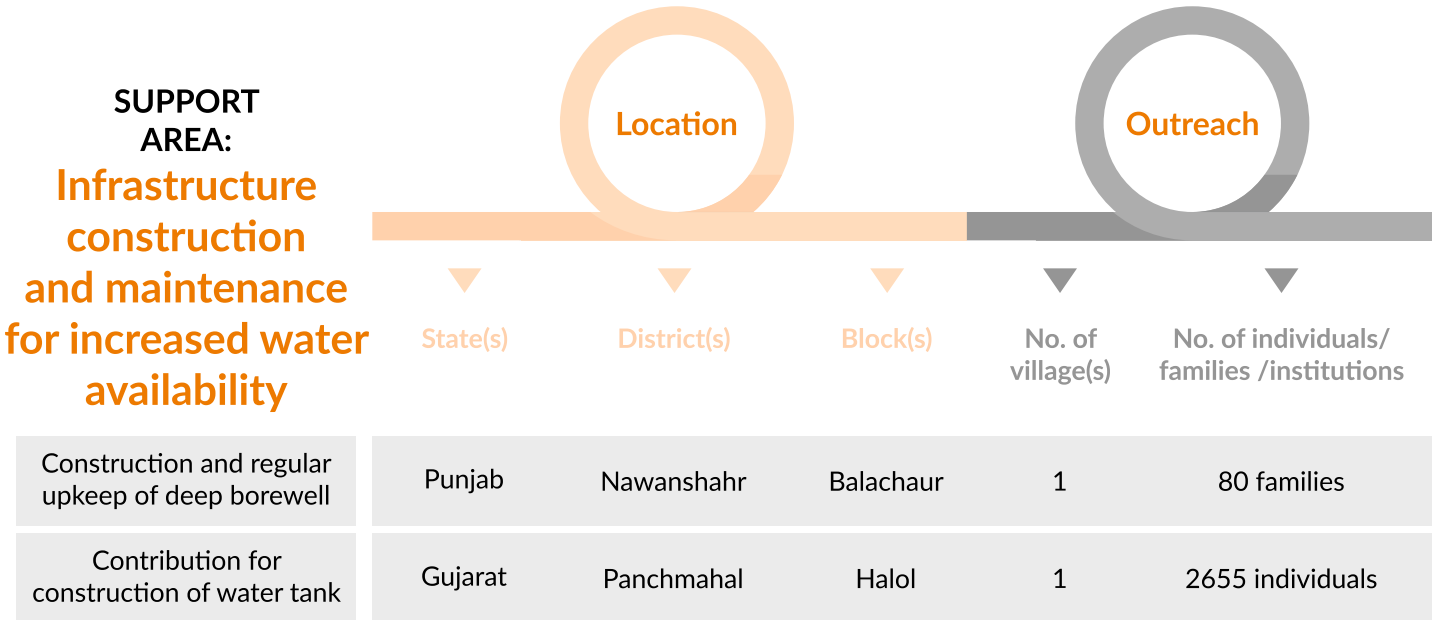

Apart from improving community access to clean drinking water, the company also engaged in construction and maintenance of infrastructure for water availability and storage.

As part of this support, a borewell that was constructed by the company in 2006 in Toansa village of Nawanshahr district, Punjab, was repaired in this financial year. This borewell ensures uninterrupted water supply to 80 families of the village.

The company also supported the local initiative of one village in Halol block of Gujarat. The local community, with the objective of improving water management in their village, decided to construct a water tank. Sun Pharma extended financial support to construct the water tank.

With an objective of improving the access to sanitation facilities for local communities and consequently curbing open defecation, Sun Pharma constructed IHHTs in villages across Tamil Nadu, Gujarat and Maharashtra.

 IHHTs were constructed in 10 villages across three states and benefitted a total of 943 families

To promote behaviour change and create a supportive environment for individuals and families to adopt the usage of IHHTs, trainings were conducted with communities with the following objectives :

- To orient communities on how to use toilets
- To discuss the immediate and wider benefits of using toilets as against open defecation
- To quell any risks or misconceptions perceived by the community in using toilets

Trainings were conducted in collaboration with local schools, Panchayat bodies and Village Health, Nutrition and Sanitation Committee (VHNSC)

Stories of safe sanitation

ACCESS TO AMENITIES FOR SANITATION AND HYGIENE SECURED



Renubai Nimse did not have a toilet at her house. Due to old age it was nearly impossible for her to go too far away from her house to defecate. As a result she defecated in the open in close vicinity of her house. Renubai was herself aware of the fact that this practice was putting her own family as well as the surrounding households at a risk of contracting illnesses that spread due to breeding of houseflies and insects. She felt helpless as she did not have the financial resources to construct a toilet in her house. As part of their household survey to assess the availability of sanitation amenities, the Sun Pharma team along with village Panchayat members reached the home of Renubai. They heard out her concerns related to open defecation and proposed to construct an individual household toilet (IHHT) for her. Renubai readily agreed and a IHHT was constructed in the compound of her home through joint efforts from NBA and Sun Pharma. "I am very happy and thankful to Sun Pharma for constructing a toilet right outside my house because now neither me nor my family need to defecate in the open", she affirmed with a wide smile.

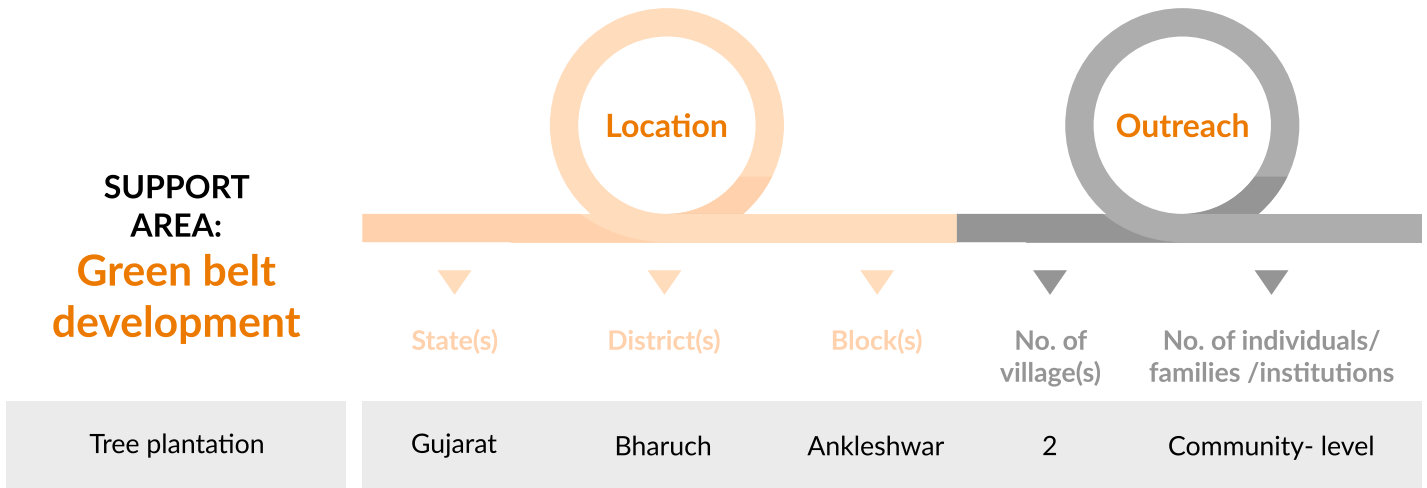

Domain 4: Promoting environmental sustainability

In today's day and age, with booming economic growth extracting natural resources at a rapid speed, environmental degradation is a growing concern. Protecting and enhancing life on land and below water is the need of the hour. Businesses are an important stakeholder in ensuring that not only are their activities in compliance with environment safety regulations but that they also contribute to environmental sustainability. To protect, restore and promote the sustainability of the environment, Sun Pharma has been working to manage forests and combat deforestation through its Green Belt Development project.



The Green Belt Development project was initiated with the objective of facilitating the sustainable management of forests, halting deforestation, restoring degraded forests and substantially increasing afforestation and reforestation in the project area. Largely concentrated in the Bharuch district of Gujarat, the main activity under the project is tree plantation, specifically aiming to counter the increasing levels of air and noise pollution. In 2016-17, 900 trees were planted in the villages of Kharod and Sanjali.

We move beyond generic tree plantation drives. We select tree species based on three-directional guiding factors.

Three directional guiding factors for selection of tree species:

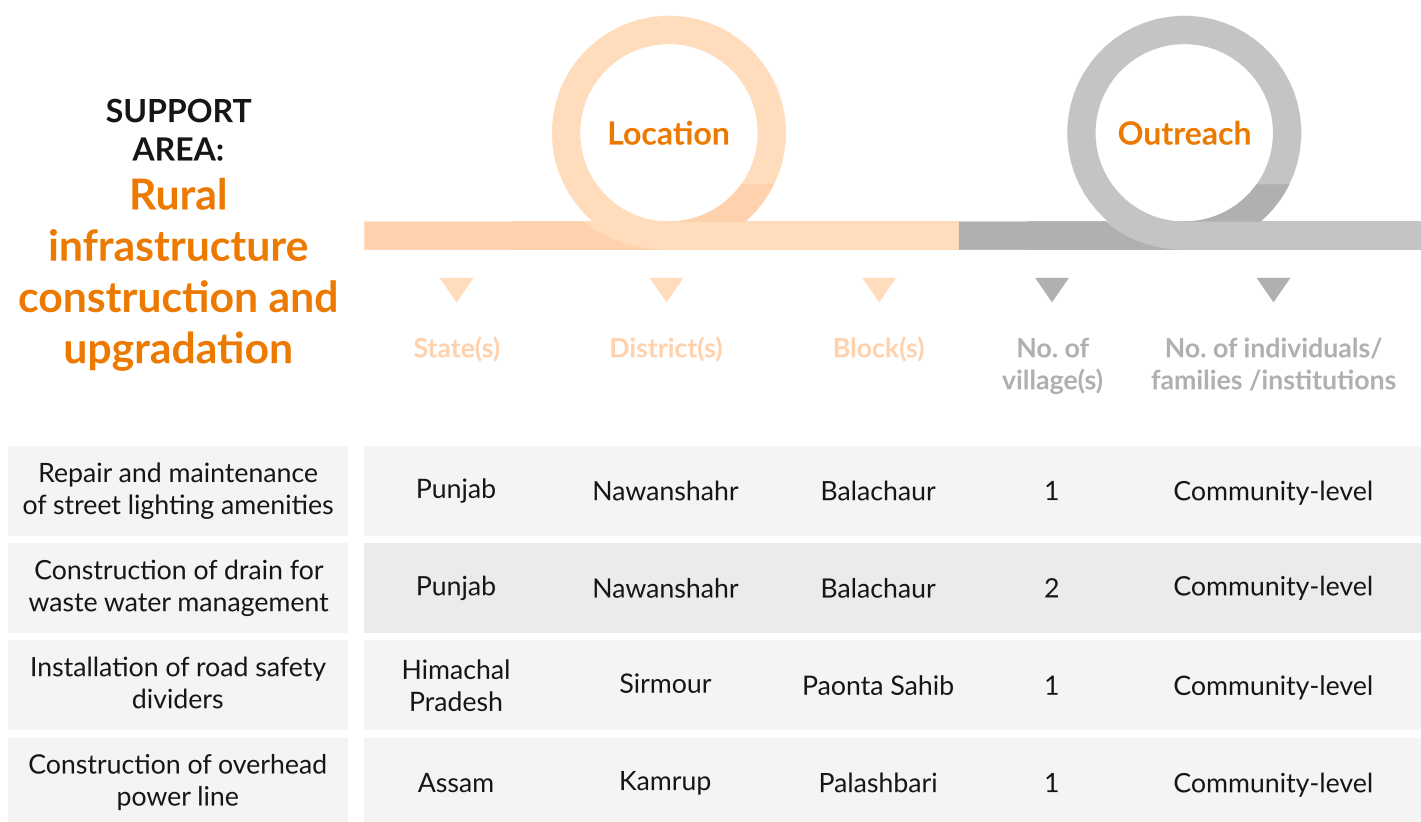
Scientifically designed and proven to be tolerant to air pollutants present in the area

Indigenous and thus able to thrive and flourish under natural conditions

Sensitive to air pollution which would act as an indicator for existing level of air pollution in the area

Domain 5: Furthering holistic village development

A large part of our country's resources are invested in urbanisation and industrialisation. Rural communities thus often remain isolated from the fruits of economic development. Villages often face the burden of unemployment, poor infrastructure and weakening governance systems. Sun Pharma has been working with rural communities in the areas of its operation to safeguard all equal rights to economic resources, as well as access to basic services, ownership and control over land and other forms of property, natural resources, new technology, and financial services.



Sun Pharma undertook rural infrastructure construction as well as upgradation in villages around its plant locations in Punjab, Himachal Pradesh and Assam. The infrastructure development activities for 2016-17 were focussed in the following areas:

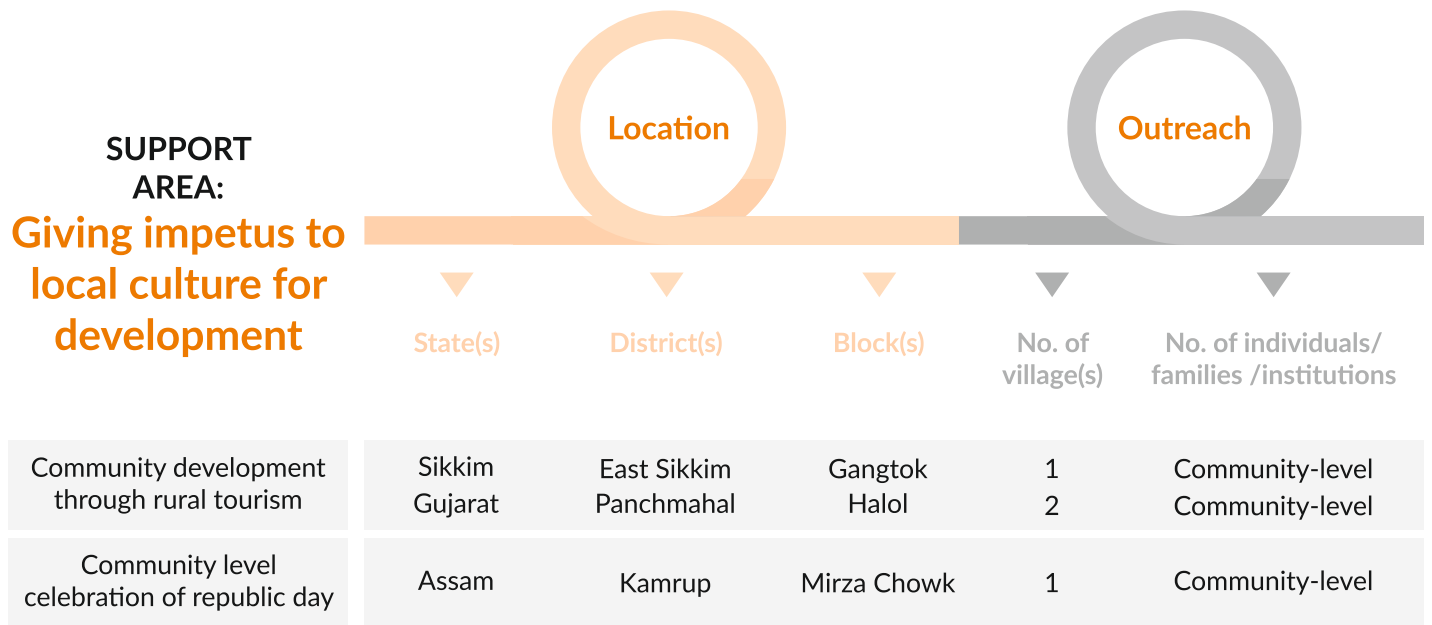
Better amenities for electricity supply in rural areas: 100 electric street lights and 10 solar street lights were repaired in Toansa of Nawanshahr district in Punjab. One overhead power line of 11 KV was also constructed at Baratoli village of Kamrup district in Assam.

Waste management and sanitation in rural areas: The road from the highway leading to the villages of Toansa and Bholewal was prone to damage by waste water due to lack of proper drainage system in these villages. To address this challenge, Sun Pharma, in consultation with the Gram Panchayat authorities of the two villages constructed a drain to manage the waste water.

Road safety: To ensure safety on roads 216 dividers were installed from Y point to Badripur chowk in Paonta Sahib block in Sirmour district of Himachal Pradesh.

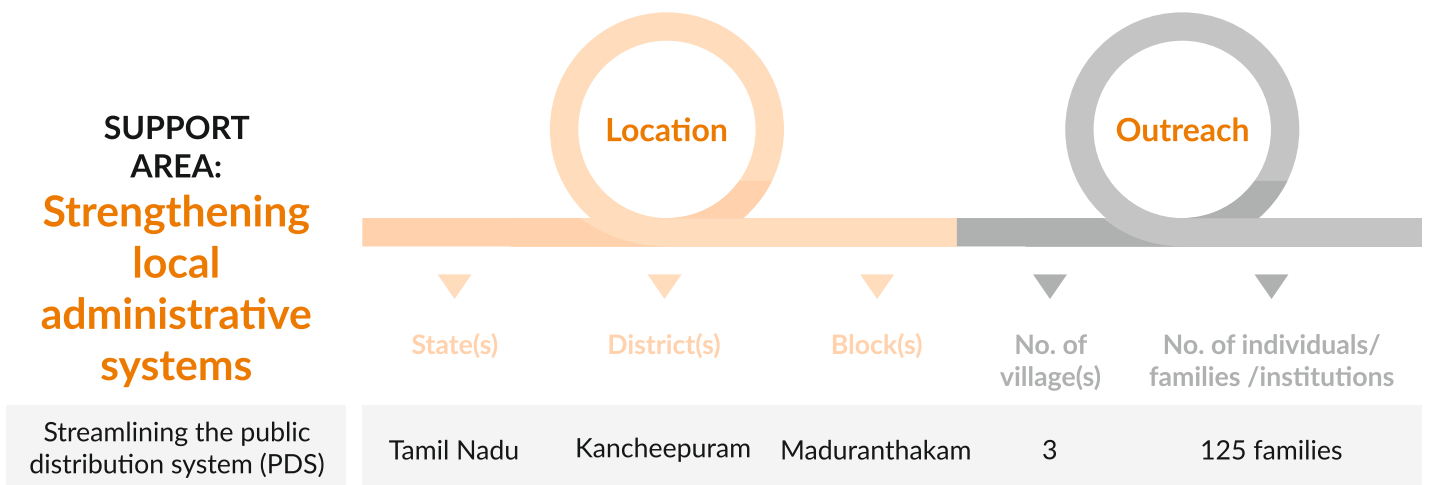

The SDGs state that culture is an important contributor for sustainable development. It has been highlighted as a tool to preserve identity, attract activities and visitors, foster the development of creative economy and quality of life.

Tourism development and strengthening as a road to socio-economic development of local communities was undertaken by Sun Pharma in the states of Sikkim and Gujarat. In Sikkim, the Sikkim Tourism Development Department was sponsored while in Gujarat, Panchmahotsav – an event to create awareness about the Champaner-Pavagadh tourism sites – was sponsored by the company.



The company has taken steps to strengthen the government's public distribution system (PDS) in Tamil Nadu. Sun Pharma came across instances of a few remote locations where the availability and accessibility of essential food grains was a challenge. To respond to this need, in 2015-16, the company had constructed a fair price shop in Sathammai village. The shop provides quality food grains to local residents and is equipped with proper storage amenities.

In 2016-17, the company's PDS strengthening initiative reached out to 125 households in three villages - Pasambur, Pillanchi Kunnayakam of Pudhupattu Panchayat. A point worth mentioning with reference to the company's work to strengthen PDS is that the management and maintenance of the fair price shop is handed over the village Panchayat. This is a successful step in increasing community ownership for sustainable development at the local level.

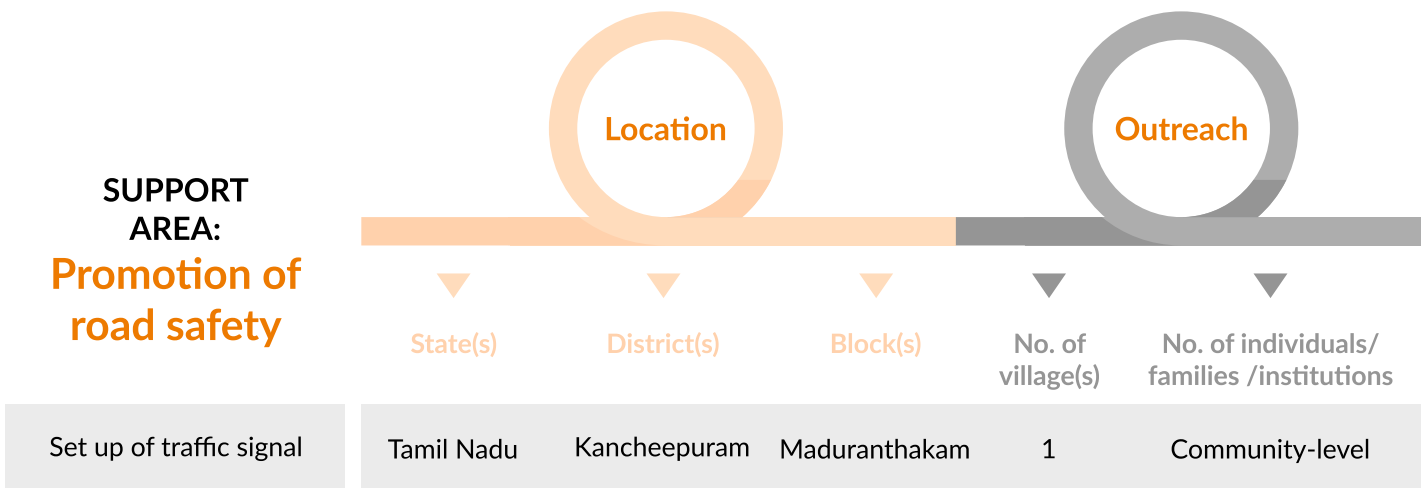

Our community has always extended its support to Sun Pharma's initiatives for socio-economic development and growth at the grassroots level. One of the community members donated his own land for the construction of the fair price shop. The shop construction by the company is now directly benefitting 125 households by making available high quality food grains.

The National Highway at Karunkuzhi in the Maduranthakam block of Kanchipuram district, Tamil Nadu is a busy route connecting major cities in South India like Trichy, Madurai, Tirunelveli, Kanyakumari and Pondicherry. Additionally, almost 80 of the surrounding villages use the highway for transportation to schools, colleges, hospitals, government and private offices.

Since 2012, a fairly large number of accidents (431 cases) were registered on the highway. One of the key issues identified by the local police department was the unavailability of a traffic signal to control the traffic flow on the highway.

Aware of Sun Pharma's efforts towards local community development, the local police department approached Sun Pharma and requested them to contribute towards setting up a traffic signal on the highway. Sun Pharma took up the project and within two months (between October and November 2016) a new traffic signal was installed.

The impact of this project has not yet been analysed in depth, but we consider it an important contribution towards the prevention of grievous injuries and fatalities through accidents.

Malaria Free India Initiative

Malaria is one of the most common infectious diseases in the world. It is preventable and treatable, yet claims more than half a million lives a year. According to WHO, one in seven people residing in India are at a risk of contracting malaria. India accounts for 77% of the total malaria reported cases in Southeast Asia.

Sun Pharma believes that eradicating malaria may be an uphill task, but it can be controlled through the combined efforts of civil society, healthcare personnel, government agencies and pharmaceutical companies. In this bid, Sun Pharma founded the Foundation for Disease Elimination and Control of India (FDEC-India) as part of its CSR initiative.

In 2016, FDEC-India entered into a first of its kind public-private partnership (PPP) with the Government of Madhya Pradesh and the Indian Council of Medical Research (ICMR). The objective of this partnership was to eliminate malaria from 1233 villages of Mandla district in Madhya Pradesh. The lessons learnt from this demonstration project will be useful for scaling up malaria elimination programme in the rest of the state and the country.



A first of its kind PPP agreement on translational health sciences, including disease surveillance and elimination was signed by Dr. Soumya Swaminathan, Director General – ICMR and Secretary Department of Health Research Ministry of Health and Family Welfare and Mr. Dilip Shanghvi on April 25th, 2016 in New Delhi.

Mitigating the Aftermath of Disasters

The Dzongu region in North Sikkim was affected by a major landslide in August 2016. This resulted in families losing access to basic amenities, local businesses getting destroyed and institutions extending services like health, education etc. shutting down. This rampant loss of lives and livelihoods called for immediate action to restore basic human rights and dignity.







We responded by providing immediate relief to disaster affected households. Disaster relief activities were conducted in collaboration with Ranipool police station.

50 sets of blankets, tarpaulin and pieces of PVC profile were distributed to 50 families whose lives and livelihoods were affected by the landslide.

Employee Engagement

Social development and growth of the vulnerable and underserved communities residing around our areas of operation is strongly imbibed in the culture of our organisation. This is not seen as only the responsibility of the CSR department, but we encourage employees at different levels of the organisational hierarchy to contribute towards the causes we stand for.

In 2016-17, activities to engage employees in local development were conducted in the states of Tamil Nadu and Sikkim.

Blood donation drive

A 2012 WHO report highlighted that India faces a shortage of 3 million units of blood annually and this problem could be addressed if an additional 2% of Indians donated blood. We consider blood donation drives as a critical contribution and annually motivate and sensitise our employees to engage in this initiative.

In this financial year, 95 employees from our plant in Maduranthakam donated 83 units of blood which was stored at the Villupuram government hospital.
